In October/September MECCA will have a firewood Work Bee to cut, split and stack in the woodshed.

#### Finance - Sondra Brown:

- Membership and Donation payments are now on-line.
- Proposed FY 23-24 Budget was discussed, and few changes were made.
   Budget will be presented and voted on at the annual meeting in September.
- MECCA received its 2022-23 RTP Grant payment in the amount of \$7,954.

### Membership - Sondra Brown

- MECCA currently has a combined membership of 97 families and individuals.
- Sondra Brown and Becca Bartling have made it possible for MECCA members to renew their Membership Dues and make donations online. Simply visit meccatrails.com and make payment using a credit or debit card or Paypal. The Board members extended their thanks to Sondra and Becca for their time and effort in accomplishing this goal. Their efforts saved MECCA service fees that would have been paid to a vendor.

## Special Events - Rodney Silvis: 2024 Winterfest Updates

- Winterfest Planning meeting scheduled for August 3 at the Mercer Community Building.
- Event generated approximately \$15,000 net profits last winter.
- 2024 Winterfest will advertise in Silent Sports Magazine and the website of Skinny Ski.
- MECCA has received a \$1,000 grant from the Mercer Chamber of Commerce to be used to advertise Winterfest.
- Teresa Schmidt will manage the RunsignUp platform to register skiers and snowshoers.

#### Trails and Equipment - Norm McKindles

- Mower wheels and miscellaneous parts were purchased at a cost of \$493.
- Trails were mowed before "Run for a Vet" by Bernie. Next mowing cycle will be in late August.
- The "Run for a Vet" was a success with over 100 participants.
- Mercer Bike Trail has been mowed three times so far this season.
- Sign Maintenance Contract with the Park Board has been nearly completed by MECCA volunteers.
- New UTV anticipated arrival of the new John Deere Gator is tentatively in October. Auxiliary lighting and grooming implement control wiring may be performed by the dealer rather than MECCA volunteers. Dealer cost for this service would be approximately \$2,000.

#### **New Business**

**Discussion to raise "Membership Dues and Trail Use -** After much discussion it was decided to raise the Membership Dues as follows:

**Motion** - A motion was made by Tim Lutgen to empower President and Treasurer to make monetary decisions (such as opening up a CD) independent of the full board. After discussion there was no second to the motion.

needed.
