Special Event: Winterfest 2026 discussed. A committee meeting will be scheduled in the next few weeks. Volunteers, dates, roles, advertising, grant monies will be discussed.

New Building: Luppino Contractor has begun constructing the equipment building. Concrete floor poured, rough grading, wall framing started. Contractor has been very responsive. Recognizing donors and grand opening event will be discussed in June.

New Business: RTP (Recreation Trail Program) Grant application submitted to WI DNR in the amount of \$12,866. Iron County Forestry is MECCA's sponsor. Successful applicants will be notified in the fall. Mercer Bike Trail Mowing Five Year Contract between MECCA and the Mercer Park Board expires at the end of the biking season. The MECCA Board agreed to meet with the Mercer Park Board to discuss the

potential of entering into another five year agreement. July 4th "Run for a Vet" liaison will be Jon and Tim, who will coordinate with Dave Lombardo on mowing the course. Firewood work bees to cut, split, stacked wood will be scheduled later in the summer.
